pregnancy discrimination and pregnancy related disability May 22 2022 if you are a job applicant or an employee who believes that an employer has discriminated against you because of your pregnancy or your pregnancy related disability you can file a charge of discrimination with the eeoc learn more about filing a charge of discrimination if you are a federal job applicant or employee in this situation you can take action by filing a complaint
