freedom of speech wikipedia Jan 05 2021 historical origins freedom of speech and expression has a long history that predates modern international human rights instruments it is thought that the ancient athenian democratic principle of free speech may have emerged in the late 6th or early 5th century bc freedom of speech was vindicated by erasmus and milton edward coke claimed freedom of speech as an the first amendment freedom of speech religion and the Jul 19 2019 18 07 2022 freedom of the press freedom of assembly and petition freedom of association history of the first amendment although the rights embodied in the first amendment were not included in the original draft of the united states constitution they were essential in its ratification after the constitutional convention several states including new 82 a bill for establishing religious freedom 18 june 1779 Apr 20 2022 02 01 2002 a petition from augusta county expressed approval of the bill presented to the last assembly and published as they suppose for the consideration of the people for establishing religious freedom and prayed that it be enacted into law another petition from dissenters in lunenburg county asserted that they had seen a bill which they suppose was
