how the census bureau measures poverty Dec 19 2021 web 22 09 2022 additionally poverty status cannot be determined for unrelated individuals under age 15 such as foster children because income questions are asked of people age 15 and older and if someone is under age 15 and not living with a family member we do not know their income since we cannot determine their poverty status they are excluded
